The reason that Preston Public Utilities is requesting that you provide us with your social security number is to allow Preston Public Utilities to be able to file a claim with the Minnesota Department of Revenue in order to recapture any delinquent utility amounts through tax refunds. Preston Public Utilities will only take this action in the event that your utility account becomes delinquent and it does not receive payment from you.

In the event that Preston Public Utilities needs to file a claim, your social security number will only be provided to the Minnesota Department of Revenue. It will not be provided to any other government agencies or third parties. You are not required to supply this information and you may still receive utility services in the event that you do not provide it.
